Eligibility

- Age of boat: up to 20 years online; greater than 20 years by referral to company.
- Age of operator: must be at least 25 years.
- Boating experience: minimum three years.
- Usage: pleasure use only.
- Business use or charter: not eligible.
- Automobile driving record:
 - No major moving violations within the past five years.
 - No criminal convictions within the past three years.
 - Total number of minor violations and "at-fault" accidents should not exceed two per operator or three for all operators within the past three years.
- High-performance boats are ineligible.
- Speed: maximum 75 mph.
- Hull coverage only: not eligible.
- Liability coverage only: not eligible.
- Stand-alone (monoline) policies are eligible.
